RETAIL FURNITURE LIMITED WARRANTY

WARRANTY INFORMATION FOR FURNITURE USED IN RESIDENTIAL APPLICATIONS*

Eco Outdoor CA, Inc. provides the following limited warranties against manufacturing defects with its Eco Outdoor furniture:

- > 5 year** limited warranty on: Teakwood, Aluminum, Steel, Brass and Stainless Steel frames;
 - > 2 year** limited warranty on: Eco Outdoor fabrics; Cushion; Weave; Fabric slings; Compact laminate;
- In case of a defect covered by this warranty, Eco Outdoor will at its discretion and without cost to the owner:
- > inspect and repair or replace the furniture (including, if necessary, removing defective furniture and redelivering repaired or new furniture); or
 - > refund its purchase value.

If furniture is replaced under this warranty, the replacement furniture will be subject to the warranty terms and warranty commencement date of the original furniture.

This warranty does not cover:

- > normal wear and tear
- > in Teak furniture, natural checking (fine cracks on the surface or ends) which may appear from exposure to the elements
- > in natural wood products, natural color and grain variations and natural changes in color over time
- > stainless steel staining from acidity or salt in the atmosphere
- > normal fading of fabric, laminates or weaves
- > defects due to furniture not being cared for or maintained in accordance with the care instructions supplied
- > any damage or defect caused by improper or faulty installation of the furniture
- > any other defect which has arisen (either wholly or substantially) from something other than faulty manufacture

Limitation of Damages > To the full extent permitted by law, this warranty does not cover, and ECO Outdoor is not responsible for, special, incidental or consequential damages resulting from any breach of warranty or condition, or under any other legal theory, including, but not limited to, loss of use, loss of revenue, loss of actual or anticipated profits, loss of the use of money, loss of business, loss of opportunity, loss of goodwill, injuries to persons, or damages to property (other than damage to the product itself). Some States do not allow the exclusion or limitation of incidental or consequential damages, so the above limitation or exclusion may not apply to you.

Limitation of Implied Warranties > All implied warranties (including the implied warranties of merchantability and fitness for a particular purpose) are limited in duration to the length of the limited warranty applicable to your product. All such implied warranties are expressly disclaimed for periods beyond this timeframe. Some States do not allow limitations on how long an implied warranty lasts, so the above limited may not apply to you.

Other Rights > This warranty gives you specific legal rights, and you may also have other rights which vary from State to State.
